## CASE STUDY: COUNTY COURT SERVICES

### THE VERDICT IS IN: NETGEAR® PROSAFE® EXCEEDS PUBLIC DEFENDER'S OFFICE EXPECTATIONS

#### BACKGROUND

Located in Bartow Florida, the Public Defender's Office, 10th District runs on an all-electronic records system that enables attorneys to immediately access files directly from the courtroom as well as other strategic locations with secured, organization-issued tablets. Everything the attorney might need throughout the case, including case records, evidence, video depositions, and histories is stored in a secure database that can be accessed wirelessly in real time. In addition to the courtroom, attorneys must have the ability to access the data from other locations, including their offices and homes.

#### PROBLEM/OBJECTIVE

##### INEFFECTIVE, UNRELIABLE ACCESS

The Public Defender's Office, 10th District had previously attempted to move to this paperless system using a Cisco wireless system. While the system technically worked, it was ineffective and failed to provide the level of connectivity required to make the migration. "The system absolutely has to work 100 percent of the time, because a person's fate is in the balance," says Tom Simmons, IT Manager for the Public Defender's office, 10th District. "If the wireless goes out while an attorney is in the middle of closing arguments in a first degree murder case, and the attorney loses the jury's attention as a result, that would have a major impact."

Tom received daily complaints about the Cisco system and the attorneys were losing confidence in the ability of the organization to meet their needs. Resolving this became a top priority of the elected Public Defender himself. Tom knew that he needed to find and implement a strong wireless system that would enable attorneys to access necessary data from internal systems and work in a fast, efficient manner. Now faced with the largest, most important IT project he's faced in his 20 years with the Public Defender's Office, 10th District, Tom turned to Eliot Lanes, President of Viable Solutions, for assistance.

Eliot recommended a NETGEAR ProSAFE wireless system to provide secured wireless communications and meet coverage and access requirements throughout the nine-story courthouse building, as well as other strategic remote locations, while remaining within budget. Tom purchased 40 ProSAFE WNDAP660 802.11n dual-band premium access points to place throughout the courthouse and a pair of ProSAFE WC7600 wireless controllers (running in redundancy mode) to centrally deploy and manage the entire system from a single console. The access points provide the reliable, high-speed coverage and reliability they require and the controller simplifies the deployment and day-to-day management of the system.

Working side by side with Viable Solutions, Incorporated, Tom began putting everything into place and testing the system. Further complicating the plan, the main Public Defender's database the system would need to access was simultaneously being switched over to a new one. "With any operation of this magnitude, you have to expect issues," says Tom. "But when those occurred, they were dealt with immediately and professionally. In all, the entire project, from the planning through implementation, has gone exactly as the Public Defender's Office, 10th District had hoped.
