




Scope 2 – Electricity Usage

2015 NETGEAR Electrcity Consumption, by site, MWh







Water Consumption

In 2015, all lawn was removed and water-saving sprinklers were installed at our Headquarter office in San Jose, CA. This resulted in a 28% reduction in water usage compared to 2014.

2015 NETGEAR Water Consumption, by site,* Gallons







NETGEAR Greenhouse Gas Emissions
